

**TOWNSHIP OF FAIRFIELD
ORDINANCE #2009-21**

**AN ORDINANCE TO AMEND AND
SUPPLEMENT THE REVISED ORDINANCES OF THE
TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX
RELATING TO CHANGE IN FINE FEES**

WHEREAS, pursuant to R. 7:7-3, the following Local Supplemental Violations Bureau Schedule of designed offenses and Payable Amounts has been approved by the vincinage Assignment Judge and shall be in effect for offenses committed on and after July 1, 2009. The Schedule shall be prominently posted for public inspection at the location of the Violations Bureau.

**NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE
TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY AS FOLLOWS:**

1. The following shall be an amendment to the Municipal Code of the Township of Fairfield, relating to Fines:

Chapter 1. General Provisions

Section 1-5.6 Fines.

Chapter 7. Traffic

Section 7-37.4 Signs, Pavement Markings, Installation and Maintenance.

The owners of the premises referred to in this section shall provide and install signs and pavement markings as required, which signage and markings shall be in accordance with the Manual of Uniform Traffic Control Devices. The cost of procurement and installation of the signs and pavement markings shall be the responsibility of the owner of the property. The owner shall, subsequent to the initial procurement and installation, maintain such signs and pavement markings in good condition at no cost or expense to the Township. The owner shall be responsible for the repair and restoration or replacement of same.
