

**TOWNSHIP OF FAIRFIELD
ORDINANCE #2010-05**

**AN ORDINANCE AMENDING CHAPTER 8-6.6
OF THE CODE OF THE TOWNSHIP OF FAIRFIELD
REGARDING INCREASE OF FEES FOR FOOD AND BEVERAGE LICENSES**

WHEREAS, the Health Department is requesting that the fees for food and beverage licenses be increased; and

WHEREAS, based upon the foregoing, the Governing Body of the Township of Fairfield desires to amend the provisions of the Ordinance as recommended by the Health Department.

NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY AS FOLLOWS:

1. Chapter 8-6.6 Fees be and is hereby amended to read as follows:

The fees for licenses and certificates under this chapter shall be as follows:

- a. All retail food establishments with a seating capacity:

0-50 seats	\$ 60.00	\$ 75.00
51-100 seats	\$120.00	\$135.00
101-150 seats	\$180.00	\$200.00
151+ seats	\$240.00	\$265.00

- b. Take out only, with no seating on premises:

0-1,500 square feet	\$ 60.00	\$ 75.00
1,501-3,000 square feet	\$120.00	\$135.00
3,001-4,500 square feet	\$180.00	\$200.00
4,501+ square feet	\$240.00	\$265.00

There are no other changes to this chapter or section.

2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
3. If any section, paragraph, subdivision, clause of provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed to be valid and effective.

4. This Ordinance shall take effect immediately upon passage and publication in accordance with law.
